

NHS/MLA TERMS AND CONDITIONS
NHS d/b/a NATIONAL HORSE SALES
MLA d/b/a MERCER LIVESTOCK INC

- 1) ALL NO SALE, FEES, OR PAYMENTS IN FULL MUST BE PAID BEFORE THE REMOVAL OF HORSE OR HORSES.
ANYONE REMOVING STOCK WITHOUT PAYING FEES OR NO-SALE FEES WILL BE CHARGED BACK AND INVOICED DOUBLE THE AMOUNT. FAILURE TO PAY UPON RECEIPT WILL RESULT IN IMMEDIATE LEGAL COLLECTIONS.
- 2) NHS/MLA DOES NOT PROMOTE PRIVATE SALES PRIOR TO AUCTION. HOWEVER IN THE EVENT OF A PRIVATE SALE TAKING PLACE ON THE PREMISES, THE FINAL TRANSACTIONS MUST BE COMPLETED IN THE NHS/MAL OFFICE. THE SELLER IS RESPONSIBLE FOR ALL FEES AND WAIVES ALL RIGHTS IF THE LOT IS RE-CONSIGNEED BY THE NEW BUYER. THE NEW BUYER IS RESPONSIBLE FOR ALL RE-CONSIGNMENT FEES. ANY IMPROPER OR FALSE REPORTING OF PRIVATE SALE AMOUNTS WILL RESULT IN A PERMANENT BAN FROM NHS/MLA AUCTIONS AND ASSESSED A DOUBLE COMMISSION FEE PLUS A \$500 PENALTY FEE RATE COLLECTIBLE BY LAW. ALL COMMISSIONS MUST BE PAID IN FULL.
- 3) NSF CHECKS OR NON-PAYMENT WILL RESULT IN LEGAL ACTION. CREDIT CARD BACK UP WILL BE REQUIRED ON CHECKS. UPON CHECK CLEARANCE, CREDIT CARD VOUCHER WILL BE DESTROYED.
- 4) NO HORSES OR STOCK ARE PERMITTED TO "TRAILER TIE OR TRAILER DISPLAY" AT FACILITIES. ALL STOCK MUST BE CONSIGNEED TO THE SALE. HOWEVER STALLIONS FOR BREEDING SERVICE FOR DISPLAY ARE PERMITTED FOR A \$100.00 FEE PER DAY.
- 5) ANY MISREPRESENTATION BY A CONSIGNOR OR REPRESENTATIVE OF THE CONSIGNOR REGARDING HEALTH, SOUNDNESS, OR PERFORMANCE OF A HORSE WILL RESULT IN A PERMANENT BAN FROM NHS AND FACE POSSIBLE LEGAL ACTION BY BUYER AND THE NHS/MLA MANAGEMENT.
- 6) ALL HORSES (STOCK), TACK, AND EQUIPMENT IS SOLD "AS-IS". NHS/MLA IS AN AUCTION AGENT ONLY. BY CONSIGNING, PURCHASING, BUYING, OBSERVING, OR DOING BUSINESS DIRECTLY OR INDIRECTLY WITH NHS /MLA , BUYERS AND/OR CONSIGNORS AGREE TO "'HOLD HARMLESS" NHS, MLA AND ANY OR ALL OF ITS STAFF, OFFICERS OR PRINCIPALS.
- 7) ALL PURCHASES MUST BE PAID FOR BEFORE THE REMOVAL FROM THE PREMISES.
- 8) NHS/MLS IS NOT RESPONSIBLE FOR ANY THEFT, DAMAGE OR INJURIES TO HORSES (STOCK) OR SPECTATORS.
- 9) NHS/MLA IS NOT RESPONSIBLE FOR SPECTATORS OR BUYER IN THE STALL AREA BEFORE, DURING, OR AFTER THE AUCTION.
- 10) NHS/MLA IS NOT RESPONSIBLE FOR CHILDREN OR MINORS. MINORS ARE NOT PERMITTED IN THE YARDS (BARN) AREA AT ANY TIME. MINORS MUST BE SUPERVISED OR ACCOMPANIED BY AN ADULT AT ALL TIMES.
- 11) ALL ITEMS PURCHASED, HORSES, NO SALE FEES, ETC. MUST BE PAID IN FULL BEFORE REMOVING FROM PREMISES.
